

CHECKLIST

FOR THE PREPARATION OF A DIVORCE SETTLEMENT AGREEMENT

When you divorce, you also part ways with your partner financially. The so-called collateral consequences need to be settled. Clarification is needed as to who keeps what, who receives something from the other, who stays in the family home, who moves out, who takes care of the children and when, who pays for the joint children.

In other words, you will have to agree on the division of assets (so-called division of matrimonial property), on the division of occupational pension assets (BVG), on the allocation of the family home, on any maintenance payments to one spouse, on child support as well as on the allocation of parental care, custody and visitation rights.

You can either reach a comprehensive agreement on the settlement of the ancillary consequences or reach a partial agreement and leave the settlement of the disputed points to the court.

The following points, among others, must be settled when divorcing:

1

Assignment of the family home

- Who stays in the home and has the exclusive right to use it?
- Who is moving out and when?
- Do you agree on this?
- If not, the court will decide. The criterion will be who is better served by the home.

Allocation of custody of the joint minor children

Since 2014, the law has generally provided for joint parental custody.

- Did you move your marital residence abroad? If yes, where and when?
- What assets are present?
- What are the liabilities?
- Bank accounts, securities, etc.
- Allocation of real estate

- Allocation of furniture and household goods
- Allocation of vehicles
- 3rd pillar assets, life insurance policies
- Other assets
- Who will take over the outstanding debts?
